Each dock will be considered, as its own structure. The fees will apply to each dock. For electrical inspections, the fee covers one inspection and one re-inspection. All other re-inspections thereafter will be subject to a \$50.00 re-inspection fee. For verification of non-electrical, the fee covers one inspection. All re-inspections for verification of non-electrical will be subject to a \$25.00 re-inspection fee.

The minimum fee for dock electrical inspection- \$50.00

Dock up to 4 wells-----\$50.00

Docks with over 4 wells-----\$50.00+\$6.00 per additional well

The minimum fee for verification of non-electrical- \$25.00

Please be advised, dock inspections will take at a minimum two weeks to complete from the time of application.

All attached buildings/ sheds to docks shall be unlocked for electrical inspection during dock inspection. If attached building/shed is not unlocked during time of inspection, the dock will fail the inspection and a re-inspection fee may be applicable.
