Dock Inspection Program Fees

Each dock will be considered, as its own structure. These fees will apply to each dock.

Electrical Inspections: This fee includes one inspection and one re-inspection. All other re-inspections thereafter will be subject to a \$50.00 re-inspection fee.

Dock electrical inspection (up to 4 wells) ----- \$50.00

Dock electrical inspection (over 4 wells) -----\$50.00+\$6.00 per additional well

Non-Electrical Verifications: This fee includes one inspection. All other re-inspections thereafter will be subject to an additional \$25.00 re-inspection fee.

Verification of non-electrical ----- \$25.00

- Completed dock permit applications must be turned into the Mid-County Fire Protection District business office during normal business hours, Monday through Friday 8 AM to 4 PM, before the inspection process will begin.
- An incomplete dock permit application or ground system inspection certification may be refused and could cause a delay in the inspection process.
- No dock permit application or ground system inspection certification will be accepted through e-mail.
- After notification of work being completed, the inspection process may take up to 10 business days but could take longer due to high inspection volume and / or emergency incidents.
