Dock Inspection Program Fees

Each dock will be considered, as its own structure. The fees will apply to each dock. For electrical inspections, the fee covers one inspection and one reinspection. All other re-inspections thereafter will be subject to a \$50.00 reinspection fee. For verification of non-electrical, the fee covers one inspection. All re-inspections for verification of non-electrical will be subject to a \$25.00 re-inspection fee.

The minimum fee for dock electrical inspection- \$50.00

Dock up to 4 wells-----\$50.00

Docks with over 4 wells------\$50.00+\$6.00 per additional well

The minimum fee for verification of non-electrical- \$25.00

Please be advised, dock inspections will take at a minimum two weeks to complete from the time of application.

All attached buildings/ sheds to docks shall be unlocked for electrical inspection during dock inspection. If attached building/shed is not unlocked during time of inspection, the dock will fail the inspection and a re-inspection fee may be applicable.
